

Cuppa for Cancer Care Terms and Conditions

1. I understand that, in organising a fundraising activity (the Activity), I am organising such event at my own risk as an independent supporter of Hope for Tomorrow (the Charity) and take full responsibility for organising the event (including the health and safety for such event).
2. I will not hold Hope for Tomorrow, their employees, or their agents responsible for any injury, loss or harm resulting from me organising the Activity.
3. During the fundraising, I agree to refer to raising money "in aid of" Hope for Tomorrow rather than on Hope for Tomorrow's behalf.
4. I agree to obtain all necessary licenses or permissions needed for the Activity.
5. I hereby confirm that I am 16 years of age or older.
6. I acknowledge that I am responsible for all costs and expenses incurred or arising in connection with the Activity.
7. I confirm I will abide by The Code of Fundraising Practice whilst fundraising in aid of Hope for Tomorrow. Please email any questions to info@hopefortomorrow.org.uk.

Donations

8. I shall pay all proceeds from the Activity to Hope for Tomorrow as soon as reasonably possible and in any case aim to do so within 28 days after the date(s) on which the Activity took place. All payments to Hope for Tomorrow shall be made via debit or credit card, cheque, bank transfer or via a secure online fundraising page.
9. I agree to encourage donors and/or sponsors to make gift aid declarations where eligible, which may enable Hope for Tomorrow to recover basic rate tax on the donations.

Materials

10. I agree that any materials supplied by Hope for Tomorrow to me for the purpose of running the Activity will only be used by me in connection with that Activity and/or to carry out fundraising activities for the benefit of Hope for Tomorrow. I acknowledge that Hope for Tomorrow owns the intellectual property rights in such materials.

Personal Data and Photographs

11. I agree that Hope for Tomorrow may use my contact details to contact me about my Activity.
12. All personal data held by Hope for Tomorrow will be handled in accordance with applicable privacy laws and Hope for Tomorrow's privacy statement which can be found <https://hopefortomorrow.org.uk/privacy-policy/>.
13. I agree that if I provide Hope for Tomorrow with any photographs or videos taken during my Activity, these may be used by Hope for Tomorrow for fundraising purposes, and I am satisfied that anyone appearing in such photographs or videos would not object to such use.

Hope for Tomorrow's Liability

14. Nothing in these terms and conditions shall limit or exclude Hope for Tomorrow's liability in respect of death or personal injury sustained as a direct result of the

negligence, breach of statutory duty or fraudulent misrepresentation of Hope for Tomorrow, its employees or agents or any deliberate act or omission of Hope for Tomorrow, its employees, or agents.

15. I will not do anything that threatens Hope for Tomorrow's reputation or name. You acknowledge that, in the event Hope for Tomorrow reasonably believes that your Activity may damage our name or reputation, Hope for Tomorrow has the right to ask you to stop the Activity immediately.

General

16. Hope for Tomorrow may vary these terms and conditions from time to time and the up-to-date terms shall be available on this website.
17. These Terms and Conditions and any dispute or claim that arises out of or in connection with them is governed by and construed in accordance with English law. The English courts have exclusive jurisdiction to settle any dispute or claim that may arise out of or in connection with these Terms and Conditions.

Yorkshire Tea free prize draw competition

12. If the winner does not respond within 14 days, they will lose their right to the prize, and Hope for Tomorrow and Yorkshire Tea reserves the right to choose and notify a new winner.
